## Tackling inequalities in the twin transition

The EU-funded **READJUST** project is developing concrete solutions to address inequalities arising from Europe's green and digital transitions. With a focus on the mobility and agri-food sectors, **READJUST** targets areas with significant environmental impact, everyday relevance, and potential for equitable change.

A key outcome of the project will be the **READJUST Observatory**, an innovative platform designed to support policymakers. It features a Policy Tracker, a long-term collection of best practices, a clear policy roadmap, and a co-creation framework and self-assessment tool to evaluate the potential impact of new policies on equality before implementation.

### Report on existing inequalities

We finalised our first deliverable focused on research results! **READJUST** partner **Fraunhofer ISI** published their report on existing inequalities in the agri-food and mobility sectors. They identified:

- **1. Life domains mostly affected by these inequalities**: knowledge and skills; natural and environmental conditions; working life; and policy participation and voice
- **2. Horizontal inequalities resulting** from differences between people, specifically race/ethnicity, age and disability
- **3. Spatial inequalities stemming** from differences between regions and neighbourhoods
